Corp.*, 362 U.S. 228, 80 S.Ct. 725, 4 L.Ed.2d 688 (1960), in which the Supreme Court addressed a Rule 23(b)(2) class action suit for damages against a railway carrier, the United States Supreme Court observed: The right of a litigant to have his cause decided in a single lawsuit is thus of greater importance to him than his desire to avoid the costs, expense, and humiliation incident to a number of lawsuits. The latter interest is protected by the doctrine of *res judicata*, [citation omitted] whereas the former is effectively a rule of procedural due process. An unbroken line of cases has consistently acknowledged that such procedural protections are an indispensable part of the constitutional right to "due process of law." [citation omitted] Unless a litigant has received the full measure of relief to which he is entitled in an action against one who has caused him injury, and that action terminates in favor of him, he has not had his day in court. *Id.* at 233-34, 80 S.Ct. at 730. The Supreme Court went on to observe that it had "consistently recognized the inherent prejudice of piecemeal trials and the danger to a trial court's undisturbed control over its own docket." *Id.* at 234, 80 S.Ct. at 730. 26 The Rule 23 Advisory Committee Note, *supra*, 5, states in part: Rule 23(c)(3) requires that there be "an express or implied agreement of the parties as to the number of suits to be brought." The provision serves a prophylactic function; i.e., it prevents parties from manipulating the class action device so as to evade *res judicata* by bringing successive suits in different forums. Of course, the provision does not preclude the implication of an agreement by the parties in advance as to the number of suits that may be brought. Parties can lawfully agree on this point in advance, in which case Rule 23(c)(3) would not apply, or they can agree on it after a lawsuit has been brought, but before the plaintiff seeks to certify the lawsuit as a class action, in which case Rule 23(c)(3) f678ea9f9e
